STEP 4: COURAGE

The fourth word on my handy 3" x 5" card was COURAGE. My sponsor said it would take courage to do a fourth step inventory; to really look at the causes and conditions underlying my drinking and unmanageable life. She said I would need FAITH to uncover the darker aspects of myself.

First, I had to tackle my resentments. I didn't even know what a resentment was and I was sure I didn't have any. Resentment meant that I revisited, in my mind, unhappy episodes from my past and re-felt the feelings. So, I started listing the people, places and things who "done me wrong" and ended up with a tidy, little list 119 items. Then, next to each item, I wrote what the cause was and how it affected me. When I was done, I was in tears. I really was the hard luck kid, the victim.

My sponsor came to my rescue. She had me answer the hard questions about each person, situation or event on my list. What were my own mistakes? Where had I been selfish, dishonest, self-seeking and frightened? Where was I to blame? I began to see that I was not so much a victim, but a volunteer. In some instances, I was the perpetrator and gave as good as I got. What an eye opener!

For example, I had a big, ol' resentment for years, against a former boyfriend. He "got me pregnant" and didn't want to marry me and so I gave the baby up for adoption. It was a nightmarish and heartbreaking situation. Then I started honestly looking at my part. First of all, I was practically knee walking drunk at the time and too drunk for birth control. Next, he really wasn't the love of my life. Then, marriage and parenthood between two drunks is not a good deal.

This segued into the inventory of my sex life. Every relationship I entered into came with my hidden agenda. I was looking for a husband who would make me whole and complete, give me self-esteem and be my perfect higher power. Rowdy bars and drunken parties are not good places to find Mr. Perfect. Needless to say, I was broken hearted and resentful a lot.

Then, I listed my fears. Once I got past the spiders and snakes and melting polar ice caps, I had to look at my real, deep, down fears; fear of being poor, fear of being alone, fear of being criticized and rejected, fear of being unloved and unwanted, fear of sickness and death. This was definitely scary and depressing. But FAITH saved the day. I didn't have to rely on my own, puny self anymore. I had a Higher Power! I could give my fears to my Higher Power.

Doing the fourth step was harrowing experience and it did take courage and faith. But it freed me from victimhood. Another bonus was I really began to see who I was and who I was not. I didn't need to believe how other people defined me. Granted, some of the things I learned about myself weren't very pretty, but I could claim my own, authentic self.

The meeting was called to order with the Serenity Prayer at 1:32 pm.

New Intergroup Representatives: Nick F.- Rincon Group Alternate and Carly V. Glad We're All Here

Secretary - Cheyanne T. Geri O. motions to approve the minutes, Nick F. seconds, motion passes.

Treasurer - Lynne L. for Dana L. We are currently at 56% of our prudent reserve. Which is slightly better than last month. Just a reminder that the prudent reserve is not cash on hand. It includes inventory and assets.

Central Office - Lynne L Federal and state taxes are done. There are 2 Home Answering Service shifts available; the 3rd Monday from 10 pm to 6 am and the 4th Saturday from 1:30 pm to 5:30 pm. Grapevine literature prices will be increasing this month, not to include Grapevine magazine. Maureen A. is the new editor of the JFT! Maureen is training as the alternate. Jim H. has volunteered to help put together Mark on the Gate. Central Office is open 9:30-5:30, stop in for a cup of coffee and some service work.

Corrections - Tom No meeting this month. Next meeting is April 15th. Have many great volunteers but new volunteers are always welcome. Please consider being a corrections pen pal with someone 3 states away. This is coordinated through GSO to insure a good match. We are also always in need of male volunteers to listen to 5th steps in prison.

Bridging the Gap - Dante G. The committee met on March 5th, with Spanish Intergroup represented. We attended the 5th step workshop at the prison on March 11th. BTG gave a presentation at the Treatment committee meeting and we now have 7 new volunteers for 12th-step list. Have new members bridging soon.

Treatment - Eric N. Our last meeting was March 1st. Bridging the Gap presented to treatment committee. We are working on reaching out to the treatment facilities from our list. We are currently receiving a lot of requests for big books in treatment centers.

Public Information / Cooperation with Professional Community - Susan K. We met on February 22 and there were 6 people in attendance, representatives from 5 home groups. We distributed pamphlets and presented information on AA at a recovery event at the VA. Some good contacts we made for future VA events. Committee members are providing pamphlets to public libraries. We have discussed more aggressively re-addressing bus stop ads. Tucson Police Department has made a request for AA Literature for police cruisers, will discuss further. Our next meeting will be March 22.

Grapevine - Lynne L. for Dennis W. The Grapevine Committee met on March 5. Our next committee meeting will be on May 7. We have reached our goal and will be purchasing the bulk subscriptions of Grapevines and La Vina for the corrections committee to take into jails and prisons. The committee is discussing a possible Grapevine event for late spring or early summer, possibly for Founder's day.

Events Coordinator - Shantaye M. The Southside group has committed to chairing Founder's Day! A group has committed to the New Year's Eve Alcathon but would like to co-chair with other groups.
