It is now, for this 24-hour period, my considered opinion that there is no such thing as a bad AA meeting or an unfriendly AA group. Wait a minute! I didn't get here at this phase in one leap!

I remember well the first phase. Anybody who could stand on their feet in AA and articulate a few words was speaking gospel and even though the very next speaker disagreed in total with the previous one, to me it was all AA and I swallowed it greedily, hook, line and sinker.

Then came the phase where I began to run all the meetings. I'd sit forward on the edge of my chair and concentrate in the hopes of putting the "right" (according to me) words in each speaker's mouth. I even went so far as to find out who the speakers were upon the occasions when I had a prospect or new member in tow, and outline to them exactly what I wanted said. The fact that I was completely exhausted after every meeting, and that I was certainly not getting very far making friends with the various speakers and that AA had been getting along somehow pretty well before I came in did not dawn on me. After all, this was for AA! I had no selfish motive!

Then came the dawn! At one excruciatingly horrible meeting where I had with me a prospect in whom I was particularly interested (just like I was in the last one--but I had forgotten that) I nearly gave up. I felt like apologizing to the newcomer. "Please don't think," said I, "that this is all of AA. You must attend many, many meetings before you can get a true picture of AA. I'll pick you up and we'll go to--" But here I was interrupted. My prospect (mine, mind you, not AA's) looking

insufferably well fed despite the poor AA diet she'd been given (according to my way of thinking) answered, "Why, this meeting was wonderful! That man, the fat one who told that joke--the one whose grammar wasn't so good--was the most eloquent speaker I've ever heard. When he said, 'It's the first drink that makes me drunk,' right away it made sense to me. You had said it, of course, but you had said so many things."

It gave me pause to think. And what I think now is that if the meeting seems poor, then my reception is poor. Something is wrong with me and I'd better find out what it is--but quick!

Later I became a *speaker*. I went hither and yon telling AAs and non-AAs what made AA tick, according to my notions. You can see, in a way, I haven't quit that. But being a speaker, I was always met with committees and great big banners with *welcome* on them. Later still, when I began to realize the insistent need to listen more and speak less, I visited still and there were no committees, no banners to welcome me. Why? I was still an AA member. I still needed all the friendliness I could get. Why was I getting the cold shoulder? What was the matter with

these people, these AA members, this group, this whole section of the country, in fact? Even in my own group, which was growing rapidly, I was embarrassed to find that some of the newer members didn't know me. Imagine! They'd come to get AA, but surely they ought to know me too!

Then I went on a 12th Step call. The gal was in a sanitarium. It was her fourth day and she was beginning to sit up and take notice. In fact, she was sitting up playing cards with three men when I got there. She tossed me a nod and went on playing. The gal gave me a glance after awhile and flung over her shoulder, "Down in Florida the AAs are really friendly. I went there for eight months. But here, why I went down here to six meetings and nobody ever spoke to me!"

I was aghast! I could understand how all the other AAs in our group might not have spoken to her but how did *I* (the great *I*) miss?

When she got drunk again as soon as she left the sanitarium and called me, she told me that she had gone to these meetings with a visiting physician and had refused to talk to anyone, other than to acknowledge introductions. She admitted that she had sullenly gone to those meetings daring anyone to speak to her, and if they did, she rebuffed them.

It made me realize that this welcome business is up to us as individuals. Welcome, if we want it, can be made. Have you ever known of an alcoholic who wanted a drink and couldn't find it? We can use that ingenuity in finding welcome. I can, that is, and when I don't, it is because I don't want it enough. It's up to me. How about you?
