IT may come as quite a shock to you to learn that I can read, and do. I am amazed at the type of books I seem to gravitate to despite my limited comprehension. I don't attribute this to AA, however. Strangely, I always desired to learn things not covered by "Foxy Grandpa," "The Rover Boys," "Frank and Dick Merriwell" and "The Liberty Boys of '76."

As a natural consequence, I gravitated to the Old Masters and I picked quite a few who had an amazing knowledge of our program. In fact, I found but few instances, from Homer to Freud, that didn't.

I found in the Bible, for instance, that old King Belshazzar had a beautiful case of DTs after drinking wine from the Temple. Stolen wine at that, mind you.

Minutes – January 12, 2014

Nancy S. called meeting to order at 1:30PM with a moment of silence followed by the Serenity Prayer, the AA Preamble, the TAIL Purpose and Ground Rules all being read. Happy New Year to all!

New Intergroup Reps: Carol M. of the Ironwood Hills Group, Patty C. of the T G I F! Group, Arwen B. of the Morning Shades Group, George C. the Rep from Sub-District 11-114 and of the Eastside Nooners Group, Carl P. of the Smoke Free Nooners Group, Max R. of the Friday Night Jung Peoples Group and Andrea S. of the Free Spirit Meeting were all introduced. Barbara G. of the Honest Open and Free Group is also a new rep.

Secretary's Report: Mark K. Minutes are corrected to reflect that in the January 2014 issue of the JFT under New Business (bottom of p.4) the last item should have read: There was a disagreement regarding the 12 Traditions of AA as it relates to the FBOF Group. FBOF chose to avoid controversy and changed it's name to "The Founders Path" and will have historical AA literature and discussion meetings at the same time and locations of the FBOF meetings. Minutes passed with correction.

Administrative Sub-Committee: Nancy S. We will be covering what was raised during this meeting.

Treasurer's Report: Trish D. The reserve was figured at \$28,924.62 which is 60% of the prudent reserve of \$48,050.00. Yet, there was a computer/banking error discovered (\$7500.00) which increased it by 13%. This brings the adjusted reserve to 73%. Also, this increase comes from personal and group contributions through the holiday alcohons. We approved the TAIL 2014 Budget. The prudent reserve stayed the same at \$48,050.00. The TAIL Committees Budgets are as follows: PI \$250, Treatment \$500, AA of the Air \$250, Corrections \$3500, CPC \$300, Grapevine \$500 and Special Needs/Accessibilities \$200, as they requested. Thank you all.

Central Office: Reggie T. (Coordinator) Lynne L. is the Assistant Coordinator. We are open Mon - Fri 9:30AM – 5:30PM. We close our register at 5:00PM. We have 3 openings on the Home Answering Service and they are: the first Mon of the month 6AM – 9:30AM, the first Tues of the month 5:30PM – 10PM and the fifth Wed of the month 10PM – 6AM (that shift only happens a few times a year). We have 2014 Grapevine calenders (\$9.50) and pocket planners (\$5.50) for sale. They are in English, Spanish and French. On our Wish List we are asking someone to help fortify the shed because it is falling apart badly. Anyone that knows how to work with wood and can help out will be greatly appreciated. The holiday Alcohons were a great success and fun was had by all. Our next Intergroup meeting is Feb 9 at 1:30PM here at Central Office.

Corrections Committee: Ted M. The Corrections Committee meets at 10:30AM on the third Sat of odd numbered months at Central Office. The new volunteer orientation is from 9:30 - 10:30AM. The committee last met on Nov 16th.

Federal Prisons: Things are going well at all 3 Federal locations. Some new volunteers are in process of getting clearance. Anyone interested in attending meetings at the federal prisons, please contact Dennis W. at 977-8149.

County Jails: Men: Need 2 volunteers for a Wed 8PM meeting, anyone interested should call Jack W. at 906-4888.

Women: Always looking for volunteers, anyone interested should call Tamara S. at 271-2401. **State Prisons:** A 4th Step Workshop took place in Dec on the Santa Rita yard. Volunteer clearances continue to be very slow in being approved.

Dennis W. spoke with the ASPC-Tucson warden, and suggested that prospective volunteers be given a 1 month gate pass, and if interested in continuing to volunteer, will complete their application paperwork within the first month, after which month-to-month gate passes will continue to be issued until the volunteer is approved and badged. The warden responded favorably, and is looking into how this suggestion might be put into place. The Queen of Heaven was touched by this plea but, being a non-alcoholic, she called in a gal named Lucia to take care of this Twelfth Step job. Lucia had been around. She knew a gal shouldn't Twelfth Step a man, so she called in another member named Virgil. To help maintain their anonymity, I won't give their last names.

Now this Virgil fellow knew his way around, all right. He took the slipping Dante by another and unknown path so that he could avoid destruction by those three great enemies of the New Man--Temptation, Pride and Avarice.

As sure proof of the fact that Virgil was an alky, even after he had got his pigeon safely past his dangers and deposited on solid ground, he persisted in carrying on, through Hell, Purgatory and Heaven.

I wonder if, as in this case, sponsorship can't be carried a bit too far?
