**PRAASA, Pre-Assembly in Flagstaff and District 11 Report** - From Kermie W. Intergroup Liaison(Full report will be read and available at Central Office.)

The highlights from PRAASA are: Approximately 2,000 persons attended. PRAASA is the Pacific Regional AA Service Assembly. It is not a voting entity that will affect the fellowship as a whole. The purpose of PRASSA is to develop greater unity among the member, groups, and Areas of the Pacific Region; to encourage the exchange of ideas and experiences; and to provide an opportunity for members to discuss pertinent aspects of AA. The Assembly and the PRASSA Committee should always foster the Recovery, Unity and Service legacies of AA. The theme of this year's PRASSA was "Communicating Our Legacies - Vital in a Changing World." There were AA meetings available as well, but PRAASA is filled with roundtables, a business meeting, panels, and forums. The speaker meeting Saturday night were two AA trustees. One Class A Trustee, non alcoholic, and one Class B speaker, who is a recovering Alcoholic.

- All the GSR's in Hawaii District have to use air travel to all Assemblies and Committee meetings.

- Nevada - always meets midway between Reno and Las Vegas for best participation in a small town at a hotel which houses a ghost of a murdered prostitute.

- Alaska is all remote communities. 44 members go to assemblies over snow, ice and by plane. They mostly have state wide phone meetings that connect them all through the week.

-Canada's District is 900 square miles, 3 x the size of Texas, has 5 islands, and many ferry and planes to get to assemblies and conferences. They are committed to service and with all those obstacles they still have 90% participation. They now have a Western AA Service Assembly patterned after PRAASA.

There was a speaker who discussed the Circle and triangle symbol - recovery, unity and service. It was registered in 1955 as a trademark. Non-alcoholic use began without permission - chips, businesses, so what to do? Are we lending our good name? GSO would have the burden to do litigation and is focused on other issues. So decided in 1993 that AA would no longer oppose any use of circle and triangle and let go and let God. Use of the symbol is now public domain. We use it as historical value and a reminder of our legacy recovery, unity and service.

-I went to Intergroup Roundtable - some call them CSRs - Central Office Service Rep. or IGR Intergroup Rep. They discussed several topics, they were: How to gain more support among the groups for Central Office, attracting the dark groups, increasing financial stability, selling non CAL at Central Office and how to better serve the groups and interfacing better with the Districts. For more information-see my full report at Central Office.

Slovakian translations are now done. When Big Book is translated, there are 2 tests, the accuracy of the text and the spirit of the message. Navajo translation happened on Chapter 5, with various attempts it has finally passed this test and will now translate the rest of the Big Book into Navajo. GSO will present this translation to the Reservation somewhere, and they will have mutton stew and fry bread.

-A Canadian Trustee from the Yukon went to Mongolia - they brought AA literature translated in Mongolian, from General Service Office.

**Pre-Assembly Report in Flagstaff - 260 Voting members - GSR's, Intergroup Liaisons and other District officers.**

-Upcoming events : April 25, 2014 is the General Service Conference in New York and the Pacific Regional Forum is in Boise, ID July 11-13<sup>th</sup>.

-There are 50 weekly Spanish Speaking meetings in Tucson and more than 100 in Phoenix. They have received translation equipment with the receivers from the past Spanish Coordinator to translate assemblies. La Vina is 18, will have celebration in Las Vegas July 26 and 27. See Grapevine/LaVina website for information.

-A motion to change verbage in Area handbook that Intergroup Liaison change from DCM to GSR status. Currently by past action states that Intergroup Liaison has DCM status which was a typo and even though the Area has acted on GSR status, they needed the wording to reflect the status of GSR. So it was voted on and is now consistent that Intergroup Liaisons are GSR status.

-The majority votes from the panels were the same as we voted on all panel topics. So they will be sent to GSO for final decisions.

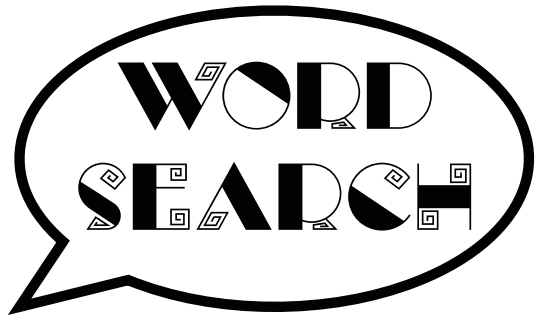
