Twenty years have passed since the doors first opened at the Eastside Meeting Place, Inc., and it has served the AA community ever since. Eastside Meeting Place is located at 6061 E. Broadway, Suite 127.

In October 1992, a group approached the leadership of an “AA Club” in Tucson and requested a meeting with no smoking - this group was told that if they wanted a meeting place with no smoking to “get your own place if you don’t like it here”! So this group, with a resentment and a coffee pot, was instrumental in starting a non-smoking environment for AA meetings in Tucson and shortly afterward the Eastside Meeting Place was founded.

Seeking guidance from our local Central Office, knowing we did not want to be a club, but wanting to follow AA’s Traditions, they recommended we file papers for a non-profit corporation. By mid-October by-laws were written and papers were filed whose by-laws state the meeting place “exists in order to operate and maintain a rented facility for the sole purpose of meetings of Alcoholics Anonymous. While this corporation is an entity wholly separate from AA, it will be guided by the principals embodied in the twelve steps and the twelve traditions of Alcoholics Anonymous”.

The first groups were The Clean Air Group, Honest, Open, and Free Group, and the Eastside Nooners, followed shortly by the Freedom Group and Our Daily Bread. Presently there are 40 meetings per week at this location with over 400 people per day attending AA meetings. The goal has always been to be a landlord for groups who wanted to rent space..

The Board of Directors (10 members per year) has a term limit of three years and there have been over 100 members since we opened the doors. These are all volunteers who contribute time and service and

CENTRAL OFFICE REPORT - by Reggie T. We need Groups or individuals to chair the Christmas and New Years Alcothons. They will both be held this year at The Tucson Women's Club, 6245 E Bellevue Ave 85712 and is near the corner of Speedway and Wilmot back behind the Trader Joe's. These events will be here before we know it so please go back to your groups and discuss these valued events. It really is important for newly sober alcoholics to have a place to go to during these holidays.

CORRECTIONS COMMITTEE REPORT - by Dante G. The Corrections Committee and the Spanish Intergroup co-hosted a Corrections Fiesta August 18th where Federal, State, and County officials spoke on the importance of this 12th step work, their relationship with AA, the relationship with the volunteers, and their gratitude as public servants.

On September 8th a 4th step workshop was held at the State prison; six volunteers presented to those behind the walls how to do a 4th step inventory. In about two months those who have completed their 4th step will have the opportunity to take a 5th step with a volunteer from AA member from the outside. The Corrections Conference has built relationships with prison and jail officials; this has allowed outside AA volunteers to do things that would not have been possible in years past-- present workshops on 4th steps, listen to 5th steps. This is important work as AA carries the message to those still suffering alcoholics behind the walls.
