Step Nine: (Recovery)

Made direct amends to such people wherever possible, except when to do so would injure them or others.

Tradition Nine: (Unity)

AA, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.

Concept Nine: (Service)

Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

Like others of the Steps, Number Nine is closely related to Number Three -- "to turn our will and our lives over to God *as we understood Him.*" If we have accomplished this step to any measurable degree, we have attained at least a small measure of humility and a realization of our dependence on Him.

Having prepared a list of all people we have harmed and brought ourselves to the point where we are *willing* to make amends to them, our Ninth Step is one calling for positive *action*. There is a world of difference between being *willing* to do a thing and actually *doing* it. How many times in the pre-A.A. state have we said "I am sorry, I won't do it again" and felt that that constituted complete amends.

A sincere apology, with a true explanation to the person harmed, of what we believe to be the reason for our past actions can quite frequently readjust personal relations --but the A.A. realizes that this cannot take care of the ones we have really hurt and invariably these are the ones we should and do love most.

Most of us had at least a few years of real pathological drinking behind us when we first learned of the Twelve Steps. Those terrible years are the ones that become repulsive to us as we progress in our new-found life program for order and happiness--years in which our every action was influenced by alcoholic thinking, with all its implications. It naturally follows that whatever our state in life may be, those close to us bore the brunt of our outrageous behaviour. How can one make amends to a dear wife, son or daughter or parent who through no fault of their own truly

- Groups represented were: Wednesday 12x12, Today Group, Women's Solutions, Our Daily Bread, TGIF!, Ironwood Hills, 801 Group, and Honest, Open and Free.
- CPC/PI Workshop: The workshop was held on July 14th at Central Office. The workshop went well. There were about 20 people present. One of the things that came out of the workshop is that the CPC/PI committee is charged with the responsibility of the CPC/PI committee to inform the general fellowship of what CPC/PI is and what the committee does. Members of the committee talked about the possibility of going out to groups to do this. Upcoming/New Initiatives
- Behavioral Health Conference: The Southwestern School for Behavioral Health Studies will be holding their 44th Annual Conference on August 20th – 23rd at Loews Ventana Canyon. They have asked us to do two things:
 - o Have a literature display during their conference
 - o Organize and hold AA meetings on Monday, Tuesday, and Wednesday nights at 7:00 pm so that the conference attendees, many of whom are in recovery, can get to a meeting.
- Sunsounds of Arizona: Broadcasts to the blind population and to other people with disabilities. Those who listen to the broadcast get a special radio from Sunsounds in order to listen to the broadcast. One of our committee members has arranged to have AA PSA's (Public Service Announcements) to be broadcast. The announcer and other volunteers will be reading AA approved PSA's from a script provided by AAWS (AA World Services). These readings will be live. As a result of these PSA's being read, there may be more calls for help from individuals who are blind or who may have other disabilities.
- Next CPC/PI Meeting: Wednesday August 22, 2012 at 5:30 PM at Central Office. Please note that there are five Wednesdays in August and the CPC/PI meeting is held on the 4th Wednesday of the month.

Direct amends, by all means, is a must, in restoring physical property to the rightful owner, paying debts willingly within our ability to do so and retracting the lie that hurt a reputation; but the real amends are made in scrutinizing our day-in and day-out conduct and keeping that conduct "on the beam." The loved ones whom we have hurt don't want their "pound of flesh." Whether they are still in daily contact with us or not, amends are best made to them by restoring the love and confidence and respect they once had for us by the *action* of right living. With that thought clearly in our minds that "first drink" is an improbability, even an impossibility and the well-rounded, good life we all yearn for becomes readily visible to us.
