10 QUESTIONS AND ANSWERS ABOUT P.R.A.A.S.A

What is P.R.A.A.S.A.? PRAASA is an AA service assembly sponsored by the areas of the Pacific Region (Alaska, Arizona, California, Colorado, Hawaii, Idaho, Nevada, Oregon, and Washington). The purpose of PRAASA is to develop greater unity among the Members, Groups, and Areas of the Pacific Region; to encourage the exchange ideas and experiences; and to provide an opportunity for members to discuss pertinent aspects of AA. The Assembly and the PRAASA committee processes focus on the Recovery, Unity and Service legacies of AA.

Who was there? There were about 1,000 registrants, mostly General Service Representatives (GSRs) from the west. There were also other Intergroup Liaisons, and lots of AA members in wide ranging past and present service capacities.

What was the agenda? I attended the Assembly, which took place on February 28 - March 3, 2013 in Boise, Idaho. Most of the activities were Friday and Saturday. We had all day activities including an orientation, 7 panels, 2 two-hour roundtable discussions, a delegate panel, a trustee report, a business meeting, a main speaker meeting, a banquet and Al-Anon activities. On Sunday, there was an "open forum" discussion, two Q & A sessions, a past Trustees panel, and a "wrap up" meeting.

What is a panel? A panel at PRAASA is an 1.5 hour meeting where 5 or so AA members share a prepared report for about ten minutes each followed by a question and answer period. For example, Panel 3 was titled "Why It Works" from 3:15 - 4:30pm on Saturday. There was a moderator, a reader, a timer, and five speakers

Minutes – March 10, 2013

John A. called meeting to order at 1:30pm with the Serenity Prayer, the Preamble, and the TAII Purpose and Procedures being read.

I have provided a report/ article of my experience for the *Just For Today* newsletter. I also plan to attend and give a report at a post-PRAASA event Mar. 16th. This workshop event is outlined to be a General Service Representative (GSR) Orientation in the morning, a pot luck lunch and a post-PRAASA highlights presentation in the afternoon. addressing these topics: 1) Tradition 1: Our Common Welfare, 2) Tradition 2: Semantics: Does Language Matter?, 3) Tradition 3: One requirement for Membership, Written or Implied?, 4) Tradition 12: Anonymity: Our Spiritual Foundation (by our own Dave B.), and, 5) The 3 R's: Rituals, Rigidity, Rules.

What was the theme? The General Service Conference Takes Its Inventory -- Our Solution In Action.

Did you meet any other Intergroup Liaisons? I attended a Central Office/ Intergroup roundtable discussion with about 25 other AA members, some of which were Intergroup Liaisons. Everyone in attendance was given two minutes to discuss their Intergroup.

Are there any other things that stood out to you? There was a lot of talk about the 12 Concepts. As I understand it, Bill wrote the concepts

to help AA prepare for its future without him and Dr. Bob. With both a three year inventory beginning this year and a proposal (and lots of opinions about) reorganizing A.A.W.S. and the Grapevine, members and panel speeches including much discussion on the concepts.

Any favorites things you heard over the weekend? Yes, a few quotes: "God doesn't call the qualified; God qualifies the called," and another where a questioner appeared to disagree with the speaker and the speaker responded: "I cannot comment on your experience."

What stood out from the Delegates review of what's happening in their areas?

Arizona's Navajo translation of the Big Book; Washington (west) holding meetings in ASL, Spanish, Korean, and Russian; Central California's outreach to homeless veterans; and Washington (east) holding quarterly workshops for service committees.

Anything else? There is still talk about changes in publishing and the extent this will affect AA coffers; and a call for people with vocational backgrounds in publishing, technology and other areas to serve on the board of trustees.
