Central Office coordinates all the meeting listings for Tucson and outlying towns, on the website, aatucson.org. On the website is also an events calendar with access to the flyers for the events. Central Office edits, updates and publishes meeting schedule booklets. Central Office publishes a monthly newsletter, JUST FOR TODAY and mails it out. The JFT can be accessed on our website and printed.

Central Office coordinates and trains people who answer our 24/7 Hotline. There are 125 shifts a month and each one is answered by a real, recovered alcoholic. Central Office also maintains a long list of people who are willing to take 12th Step calls. Central Office lists a phone number in the Yellow Pages. Central Office orders and stocks, for sale, all the AA World Services literature and pamphlets, all the Grapevine publications and all the sobriety chips from 24 hours to 65 years. These can be purchased Monday through Friday, 9:30 AM to 5:30 PM in as small or large a quantity as needed.

Central Office is a clearing house for information between individuals, Intergroup, committees, District, Area, and General Service Office. Central Office provides meeting space for 11 weekly meetings, Intergroup monthly meetings, and Service Committee meetings.

Central Office does all the bookkeeping on QuickBooks for all contributions and expenditures; alcohons and committees; literature and sobriety chips; purchases and sales. Central office prints lots of free leaflets, makes Newcomer packets, New Group packets, New Intergroup Rep packets. We are here to serve individuals, groups and Intergroup.

How does Central Office do all this? We are supported by group and individual contributions. But, like almost three years ago, our prudent reserve is very low. Groups can only contribute by what they get in the 7th Tradition baskets in each meeting. Some groups contribute nothing at all, while still enjoying the services Central Office provides. \$1.00 in the basket is so 1970's!

Minutes - December 9, 2012

Ned B. called meeting to order at 1:38 with the Preamble of AA, the Purpose of Intergroup and the Ground Rules of the Meeting being read.

New Intergroup Reps: Anne M. from 12 Stepping Sisters, Larry R. from Smoke Free Nooners, Francis B. from 445 Solutions Group, Bret S. from Fire Pit at the Ranch & SNYP Pima Alano, were all introduced.

Central Office: (Reggie T.) Central Office hours are Mon. - Fri. 9:30 to 5:30. Volunteer opportunities there are available and always appreciated. There is one shift open on the Home Answering Service. It is the 2nd Fri. from 6 – 9:30am. The 12 Step list is in need of volunteers to serve the alcoholic who is still suffering. Central Office now has in stock AA chips for each month as well as the 18 month chip. And too the 2013 AA wall calendar and pocket calendar are both available in limited quantities. The new Tucson Area Meeting Schedule is at the printers and should be available next week. Both alcohons are being organized and held at the Tucson Woman's Club, 6245 E. Bellevue Ave. It is asked that home groups and individuals bring hot food which is ready to serve and eat as no cooking will be done on site. Central Office has 2 items on their wish list. One: A new volunteer desk for the office, as the current one is in dire disrepair. Two: A full time Events Chair Person, as that position was vacated and it has fallen on Reggie. The Tucson web-site, www.aatucson.org is 2nd to none and received a total of 5076 hits for the month of Nov. And remember you can print the monthly Just For Today newsletter from www.aatucson.org. The next Intergroup meeting will be on January 13th at 1:30pm at Central Office.

Corrections Committee: (Dante G.) Budget is 0. Some discussion on how to get literature, Dennis W. had mentioned 10 books were at large for the committee, and that it might hold us over 'till next year, also the Christmas alcohons might bring in some more books. A couple of reps were going to bring request to their groups. If we could get group rep e-mails to e-mail request. Federal – things are going well at all three facilities FCI, USP and the camp. The meetings are well attended, and we have sufficient volunteers. Things are going well at the State prison also. The director of ADOC will be featured speaker at this years Area 03 Corrections Conference which will be taking place in Phoenix in January. Warden Schroeder will also be speaking. SACRAC had recently closed, will now reopen at Southern Region Community Correctional Center on Dec. 1st. It will house male post parolees and parole officers, the meetings will be coed. They have made clearance super easy. Contact Dennis W. at 977-8149. Pima county jail – they have a Wednesday night slot open for a male. Call Dante G. 975-6043. Jack had presented information on peer led meetings, but was shot down for approval by facility. Had a good turn out for new volunteer apps, but always looking for more volunteers. Would like to see Intergroup Corrections budget increased. On the female side all meetings are currently full, except 2nd Monday at 7:30pm, there is only one woman for that night, and would like to have another. Old business – putting together an Ad-Hoc committee for Corrections Fiesta 2013/ cooperation from the Spanish community. Voted in Jamie G., Richard V. and Dennis W. will consult. New business – review format of a 15 year old flier used in corrections meetings. Terry S. is compiling a binder of info for committee to have hard copies of all documents. The Correctional Facility Committee meets every 3rd Saturday (odd months) at 10:30am at Central Office. There is a new volunteers orientation at 9:30am.

Treasurers Report: (Reggie T.) Current Prudent Reserve is \$14,656.61. This is 31% of the Prudent Reserve of \$47,096.00. It is projected that this will fall to 21% by next month. The biggest reason for this is that Central Office is not receiving group contributions. Please ask your group to support all that Central Office does and is responsible for doing. Remember that if your group isn't contributing to Central Office you can always make a personal contribution. Ned B. reminds us all that in the 1970's, \$1.00 was the average contribution put in the basket. And now that it is 2012, \$1.00 is the average contribution put in the basket. Additionally, as we head into 2013, I would like to discuss what our Area 03 has scheduled: *January 18 – 19, Corrections Conference, Peoria. *March 1 – 3, Pacific Regional AA Service Assembly (PRAASA) in Boise, Idaho. *March 29 – 31, Pre-Conference Assembly, Tucson. *June 15, Post-Conference Assembly, Phoenix. *August 30 – September 1, Area 03 Convention, Tucson. *August, Arizona Area Assembly, TBA. *November, Arizona Area Assembly, TBA. Additionally, there are monthly meetings scheduled at the Intergroup on the 3rd Thursday of each month. I am hoping to attend most of these. I am requesting the same budgeted amount for expenses as 2012. Thanks for letting me be of service.

New Business: A new permanent Special Events Coordinator was elected, Elizabeth T. This will be a full 2 year term position.

Nancy C. the Christmas Alcothon Chair can use volunteers and a Food Chairperson. It is asked that home groups and individuals bring hot food which is ready to serve and eat as no cooking will be done on site. Thanks are given to the Sunday Morning Eastside And Jung People Groups for Co-Chairing this event. And also thanks to all the great volunteers from the In-Balance for Living Facility.

The New Years Alcothon needs Co-Chairs and to ask that home groups and individuals bring hot food which is ready to serve and eat as no cooking will be done on site.

Ned B. of the Administrative Committee: motion; Cost for all literature and chips will be raised by 20%, rounded to the nearest ½ dollar, and shall be reviewed in one year. This increase will remain in effect for the full year regardless of excess over 100% of prudent reserve. Monthly chips will go from .50¢ to .60¢ and yearly chips will go from \$1.00 to \$1.20
