Minutes – June 9, 2013

Nancy S. called meeting to order at 1:30pm with the Serenity Prayer, the AA Preamble and the TAIL Purpose and Ground Rules being read.

New Intergroup Reps: Gary Z. of the Oro Valley Men's Stags meeting, Jennifer B. of the Solutions 4:45 group, George C. of the East Side Nooners group, Matt M. of TGIF, as well as, Candy H. the new AI-Anon Liaison and Matt M. the new Spanish Liaison.

Secretary's Report: (Mark K.) Minutes approved as written.

Treasurer's Report: (Trish D.) The current prudent reserve is at 49% with \$23,737.95 of \$48,050.00. Group contributions more than doubled. Thank you all for your support. Please continue to help support TAIL by getting your meeting and group to contribute.

TAIL Sub-Committee: (Nancy S.) We met at 12:30pm. Here is an update for Project Gratitude: The board members are continuing to make announcements at meetings thanking groups for participating by contributing financially to TAIL and also validating that they have an Intergroup Representative and if they do not have one we are kindly suggesting that they get an Intergroup Representative to participate at the TAIL meetings. We are about 20% through the list and will continue to keep making announcements and continue to give you an update each month.

Central Office: (Lynne L.) Central Office is open 9:30am to 5:30pm, Monday through Friday. If you show up to do service work, we'll put you to work if we have any projects that need doing. If not, have a cup of coffee and chat with us awhile. Central Office purchased a new window air conditioner for the back office. The old one died. The cost was \$184.69. Now we are waiting for an A/C volunteer to install it for us. ●GRAPEVINE publishes many different books. They are compilations of GRAPEVINE MAGAZINE stories, each one relating to a different sobriety topic. A relatively new book is, "HAPPY, JOYOUS AND FREE, The Lighter Side of Sobriety." If you want a sobriety lift, read this. It is a great book and well worth the economical price of \$13.00. ●The Founders' Day Event was a great success! Many thanks to the Happy Destiny Group for organizing it and many thanks to all the volunteers who pitched in to help. Thanks to our own Sub-Committee for setting up a table with pamphlets about Central Office and Intergroup.

●The Tucson web-site, www.aatucson.org is a great way to find out all that is happening with AA in Tucson. The next Intergroup Meeting is Sunday, July 14th, 2013 at 1:30pm. Thanks for letting me be of service Lynne L. Assistant Coordinator.

Corrections Committee: (Pat S.) Our committee met on May 18th here at the Central Office. Reported was as follows: **Pima County Jail;** Everything is going well with PCJ. Except for the occasional lockdown. We really need more volunteers for the Saturday morning meeting for the East facility at 10:30am on Saturdays and 6:30pm on Sundays. Also we need back up volunteers for all meetings. I have attached a flyer for volunteers. Please bring to your homegroup. Bob points out that some people are bringing the paperwork directly to the jail rather than give it to Jack so that Jack knows who is cleared. **Federal;** Things are going well at all three Federal locations: FCI, USP (United States Penitentiary), and Camp (minimal security federal camp). We have regular Monday meetings at the FCI, Tuesday meetings at the camp, and Thursday meetings at the USP. The meetings are well attended and we have sufficient volunteers. **State;** Things are also going very well at ASPC-Tucson. There have been no major disturbances in the last couple of months and all meetings have been doing well. We are in the process of scheduling fourth step workshops for Cimarron, Santa Rita, and Winchester. Any regular badge volunteers who would like to attend are welcome. Please call me at 977-8149 for further information. Getting **new volunteers** through the clearance process is still very slow and the applicants have to be motivated and have to stay on top of the HR Department. We have to call them as they are not going to call us. ●The Southern Region Community Correction Center which opened last December still has two meetings going. This is currently the only community corrections center in Arizona. It offers an alternative to housing technical parole violators at a fraction of the cost rather than returning them to prison and is housed where SACRC (former women's facility) used to be. As the center's population increases attendance we have been steadily getting more attendance at the meetings. Clearance at that facility is very easy and only requires a brief background check. During discussion Dennis pointed out that there does not have to be any expense to getting cleared. The TB test is free if you get it done through Human Resources at the prison, but it is a long drive. One can also get it through the Health Department and it costs \$15. One can also go to CVS for the drug test if it is more convenient. ●Some discussion about peer-led meetings and sponsored meetings and the problems with cross-talk. Peer led meetings become cross talking meetings. Dennis says that it is helpful to meet with the peer leaders who are running the meetings and explain the GSO pamphlet and how to run a meeting. The more prepared the leader is the better the meeting will be. At the Winchester yard when there was a problem the sponsors reported that they stopped the meeting to have group conscience and it is a continuing process to give them the tools they need. ●Also discussion about the importance of the primary purpose of AA and the importance of duly addicted inmates attending NA meetings as well. **Sells;** Bob M. reports that there are plenty of volunteers at Sells, as well. Bob had a request for a Big Book in Arabic, he had to order and has received through our committee. **Pre-release;** Kim reports that she was able to connect an inmate with someone on the outside. She wrote to the prisoner and shared some of her ESH and then asked where he was released and when so she could coordinate with someone in that area. ●**Old business;** Dante passed out a copy of the "Suggested Correctional Facilities Meeting Format," which we looked over last time. We voted to change the word "responsibility pledge" to "responsibility declaration" and to delete reference to contact information on "yellow flyer" to "on the back." ●**New business;** Corrections Fiesta does not have a date yet. Richard and Dennis have volunteered. District 11-114 may have funds if we were to attend and ask for assistance. Kim makes a motion that we will have the Fiesta in August. Richard will call our DCM and Dante will also attend to District meeting. We will need to find a new recording secretary after July. ●**Groups represented;** Smoke Free Nooners, Southside, Our Daily Bread. ●Next meeting will be July 20th- Central Office 10:30am, new volunteer orientation @ 9:30am. amount is out. So we stop drinking. That takes care of our number one problem.

We must be willing to accept help of all kinds without resentment. This takes a little time, as we are the world's most sensitive persons. We know too well that we have neglected all of our talents and abilities for alcohol, and we have terribly guilty feelings, made more acute by persons who are already in better circumstances than we are. Nevertheless, we learn to suffer our hurt feelings and start building a constructive, happy life.

Defending what we call our "pride" is one of the most difficult shortcomings to remove. Many of us have thought of pride as something

virtuous, something to be honored. Well, what have we left, we who are humbly seeking help, that we can put on exhibition as virtue? Often we cannot actually put our finger on anything in our make-up of which we are really proud. So we break down our false pride, and exchange it for humility.

The most beautiful art in the world is simple, with few lines, little fuss and complications. So we try being simple for a change. Just plain honest simplicity. We look for the best in our fellow man, "Pardon the wrong in him; hark to the song in him."

By accepting God's help, we learn to think clearly; to play fairly; and to give generously.
