STEP 6: WILLINGNESS

The sixth word on my trusty 3" x 5" card was WILLINGNESS. From my fourth step inventory, my sponsor helped me create a list of character defects that had been sabotaging my life. She said I had to be *entirely ready* to have these defects removed. She said my Higher Power was not going to play tug of war with me. I thought Step Six was a no-brainer. Who wouldn't want to be rid of these pesky and harmful things? However, she said, we had developed our defects from childhood. They were ego defenses and we believed them to be necessary to our survival. It would not be so easy to be willing to let them go.

My character defects included the usual suspects; resentment, worry, guilt, self-pity, dishonesty, selfishness, self-centeredness, people pleasing, *ad nauseam*. For me, the worst of the bunch was jealousy in romantic relationships and this had plagued me since I was a teenager. As an adult, I dealt with jealousy by drinking good ol' booze. Now I was sober. Yikes! So, my sponsor suggested that I look at each character defect and determine what I believed it did *for* me. Then I was to look at what it did *to* me.

For example, when I was just a few months sober, I had a boyfriend, who was in my home group. He had seven years of sobriety and I was absolutely over the moon! After a few months, he broke up with me. He said, that while he loved me, he wasn't "in love" with me. He was in love with another woman in our home group, who had been slipping and sliding in and out. Since I had the emotional maturity of a two year old crescent wrench, I fell apart. I was so jealous, I had a stomach ache, a throbbing head, hot and cold sweats and waterfalls of tears. I called in sick and stayed home alone in my misery. I could see what jealousy was doing to me, but I sure couldn't see what it was doing for me.

My sponsor had me write more. I began to see that I had again, staked my life and happiness on the love of a man. His love would prove that I was really O.K. and would miraculously heal me of being inadequate, defective and deficient. So, when he left, I was flattened. I saw no benefit in this either. My sponsor said, keep writing. Since he was gone and in the arms of his true love, what did I think of him and her? I thought he was a jerk, a heel, and a toad. She was a snake and was just using him to cleanup her messes. I may have been the injured party, but I was vastly superior to them. Bingo! That was the payoff. Yes, I was jealous and miserable, but morally superior. Ego is very clever.

My sponsor pointed out to me that underneath my jealousy was my erroneous belief that I was indeed defective, deficient and inadequate. This was patently false. It was this erroneous belief that needed to be removed. She also said that I could not find wholeness in another person. I could only find healing and wholeness in my Higher Power. After all this work, I finally had the WILLINGNESS to let this defect go. And I did this same process on all my other defects, too. I began to see how very valuable WILLINGNESS was in letting go and was entirely ready for healing.

The meeting was called to order with the Serenity Prayer at 1:32 p.m.

New Intergroup Reps-Sofia- Stone Sober, Sarah- 12 Stepping Sisters, Kathleen- 12 at 12 (alternate), Cesar- Footloose **Grapevine – Dennis W.** Please encourage your group to elect a Grapevine representative if they do not already have one. There is a new Grapevine book that just came out about making amends. The committee is thinking of hosting a workshop based on this event.

Secretary's Report – Cheyanne T. Karen T. moves to approve the April minutes, Kelly seconds, the motion passes.

Treasurer's Report – Dana L. We are currently at 50% of our prudent reserve. Personal contributions are down. In order for Intergroup to function, it needs individual and group participation, especially financially. We still need participation with hitting the dark meetings.

Central Office – Jim W. Federal taxes have been paid. We have answering shifts currently available. It is a once per month commitment. This service only takes a 30 minute training, and one year of sobriety to get started. A group has volunteered for the New Years Alcathon but they need help. The Christmas Alcathon is still open. Central Office is open weekdays 9:30 A.M. to 5:30 P.M. Stop in, say Hi, have coffee, and maybe do a little service work. We will have a paint party coming up soon; more to be revealed. June 11th is our next Intergroup meeting.

Corrections – Tom T. The AZ area Corrections conference was well attended. The main speaker was the woman who does programs for Maricopa County. The administrations of the prisons seem to love AA. The committee had our quarterly meeting in April with good attendance and the possible move to district was discussed. If the move is approved at District, it will not occur until the end of June. The committee will still have a Corrections report at Intergroup. Please encourage your group to elect a representative if they do not already have one. The Corrections conference may be in Tucson next year! However, this is just an idea for now.

Bridging the Gap – Ted M. for Dante G. The committee did a presentation in Sierra Vista and one in Tucson this month. We are available to do a presentation at any homegroup business meeting. We attended the Corrections Conference and had a nice time.

Treatment – No Report

Public Information / Cooperation with Professional Community – Susan K. & Ken C. Had a good turnout at the April meeting; 11 people attended, 9 homegroups were represented. We will be attending Founder's Day on June 10th, a Veterans resource fair June 13th, and the San Xavier Alcathon June 17th. We are still researching bus stop ads.

Events Coordinator – Shantaye M. Please let your groups know the details of Founder's Day and that the committee could always use volunteers for service. The committee has compiled all the regulations for a successful Founder's Day. All Intergroup committees will have a table with information. Christmas Alcathon still needs host group.

Historian – Alan S. Met with Nancy R. and she gave me all of the materials she collected and made a back up copy of her round table from 2012. There are 2 handouts, one for group history and one for old timers. The handouts will be available at our table at Founder's Day. Next year will be the 75th anniversary of AA in Tucson! I would like to have the second Mark on the Gate volume published then.

Dark Meetings (Ad-Hoc) – Dana L. Please contact me if you have visited any of the dark meetings.

Spanish Speaking Liaison – Katrina There will be an anniversary celebration at Old Pasqua Yaqui Community Center on May 20th for Grupo Empezar a Vivir.

Area Liaison/Vice Chair – Ted M. I attended the Intergroup Liaison Round-table at the Pre-Conference Assembly in Flagstaff. Three topics were presented by the roundtable members and discussed. 1. Getting people involved in Intergroup, and finding ways to fund Intergroup within the Traditions. Some ideas were: support and educate Intergroup reps rather than just giving them the position, orientations, use literature to help educate groups about what the Intergroup does and why these services require funds. Use "Self Support: Where Money and Spirituality Mix." 2. Consistent Representation from Groups at Intergroup. Some ideas were: form Ad-Hoc Committee or standing Unity Committee to search out dark groups, provide information and ask for support through representation instead of funds at the initial meeting (funds will come eventually with representation), use a short, simple invitation like "You're cordially Invited to attend our Intergroup!!" with a few sentences about what Intergroup does, form an archives committee to generate interest in our history, attend business meetings, ask the group how Intergroup can serve the group, cooperate with Sub-Districts to get the word out about Intergroup and their services. 3. Ideas for Intergroup Sponsored Events. Some ideas were: New Years Eve Dinner/Dance, Day of Service, Founders Day, Sponsor-Sponsee Brunch, Day in the Park, Fishing Trip, Anniversary Dinner, Free meals at Thanksgiving & Christmas Alcathons. If the events break even, it's a success. Promote our primary purpose

Al-Anon Liaison – Mike M. Founder's Day will be in July at St. Francis Cabrini. We had our 2nd Al-Anon meeting in a Corrections facility. We are looking to expand our corrections work. We have some of the same trouble with dark meetings, had some success bringing surveys to groups about how Intergroup can help them & spread the message.

On June 15, the Honest Open and Free (HOF) Group celebrates its 25th anniversary. On that date in 1992 that HOF met for the first time in a now-closed bookstore in Monterey Village Shopping Center at Speedway and Wilmot. The group's stay there was brief, however. The owner of the bookstore wanted to have all the monies collected from meetings, which caused a big conflict and prompted HOF to look for a new meeting place.

On October 15, 1992 the Eastside Meeting Place was founded in the back room of a dry cleaning establishment in the same shopping center, in a building that's no longer there but was where Beyond Bread is currently located. HOF was one of the first four groups to hold meetings there. All of those four groups—Clean Air, Eastside Nooners, Today, and HOF—continue to meet at Eastside Meeting Place.
