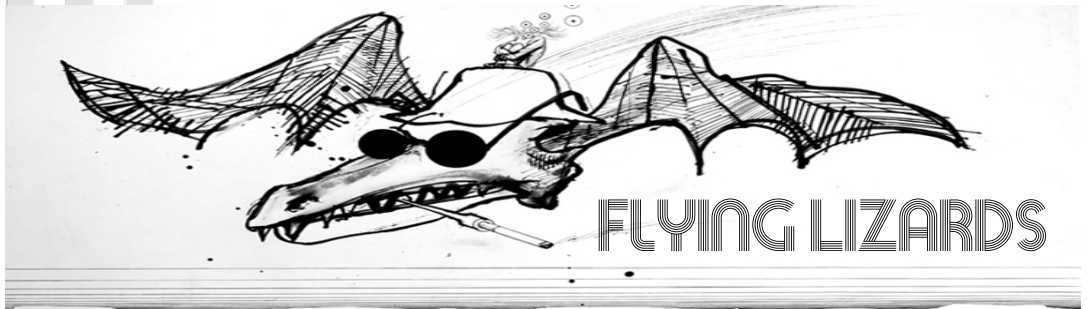

I STOPPED butting my head against the stone wall only after a full year of knowing about A.A. but not getting in touch with them--for all the standard reasons--even after I knew something had to be done. From what I hear, many others continue to shy away, months and years, from inquiring even deeply enough for the general idea. And we all seem agreed that our lifeline is that helping hand to those still in the squirrel cage, who really want the way out.

When I did get my feet wet in A.A., having skimmed through the book and attended a few meetings, I was ready to tell these amateurs a few things about organization; verily, how the bug ate the cabbage. Then came a portion of serenity. As they say of watches and cartoons, "The instant you take it apart to see what makes it tick, she stops running." I am no longer a reorganizer.

But wouldn't we like to avoid scaring the newcomer away after his first meeting, sometimes that first interview? Shorten that head-butting period? Do we keep aware that he's in a fog, worried, shaky, miserable, permeated with fear--the most primitive of all emotions? Your own memory of that can dim quickly. Okay, you get the man to a meeting. You know those flying lizards won't hurt him; he really knows they're imaginary--but he ducks every time they come at him. He's been told that his religion, if any, matters not at all. He can be anything. He must only find faith in a power higher than himself. . .you know it takes some searching for a conceited drunk to think of anyone, offhand, greater than himself. Yet the complete atheist is a rare bird. Fine. The speaker (for example, a type I find averaging about one in four) leads off with reassurance that religion was checked at

Secretary's Report: (Shane C.) January 2013 minutes are approved as written.

After some decreases of different departmental budgets there was a total of \$1908.00 increase in the 2013 TAIL budget.
