Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration

STEP 5: INTEGRITY

The fifth word on my list on the 3" x 5" card was INTEGRITY. I only vaguely understood what that meant, so I looked it up. It meant being complete or whole; upright, honest and sincere. That sounded good. My sponsor said it was being the same on the outside as I was on the inside. It was the beginning of giving up the game of "let's pretend". I was always scared that if anyone knew what I was really like inside, they would leave me. I was afraid they'd discover the monster within or even worse, the little, boring nothing.

At that time, I was working as a counselor in the Alcoholism Unit (ha! the blind leading the blind) in the Ft. Bayard Hospital in New Mexico. So, I made an appointment to do my Fifth Step with the staff psychologist. I was terrified. On the way to see him, I was fervently hoping to be run over by a bus. Then I would have a darn good excuse not to do a fifth step. However, on the hospital grounds at Ft. Bayard, New Mexico, there was a dearth of busses.

I did my Fifth Step. Miracle of miracles, he didn't run screaming from the room with a look of horror on his face. In fact, he thanked me for sharing all that stuff with him. He said that while some of it was unpleasant and painful, he was grateful for my honesty. He wished his patients could achieve that degree of honesty so they could heal more easily. The ordeal was over and I didn't die, nor was I reviled or shamed. I was okay.

Some people say that after they do their Fifth Step, they feel as if the weight of the world were lifted from their shoulders. I didn't experience that, but I did notice a certain lightness and easiness of being. I felt more comfortable in my own skin. I became more comfortable sharing the real me with others.

I heard in a meeting once, that love is the truth shared; the truth about myself. When I shared the truth about myself and was accepted for being myself, I knew I was in the right place with the right people for me. If, for some reason, I was not accepted, then that wasn't the place for me. However, I did not get over old habits right away. I sometimes stayed with people or situations that were not accepting and reverted to my old, lack-of-integrity-people-pleasing-ways. And it never worked. Through trial and error over the years, I gradually began to practice INTEGRITY in all my affairs and didn't get caught up in dismal situations.

It was exhausting, playing the "let's pretend" game, trying to please each person I encountered. Practicing INTEGRITY is so much easier! Fortunately, I don't have to be perfect. I can just be myself, warts and all. And that's okay!

Tucson Area Intergroup, Inc. (TAII) Committee Meeting Minutes — April 9, 2017

The meeting was called to order with the Serenity Prayer at 1:35 p.m.

New IGRs- Jules- Stone Sober, Wally- Friday Morning Fun, Alison- Sahuarita Brand New

Secretary's Report - Cheyanne T. Denise B. made a motion to approve the minutes, Geri O, seconded the motion. The motion passed.

Treasurer Report - James W. for Dana L. We are currently at 57% of our prudent reserve. Intergroup is still relatively low on contributions and liquid assets. Please encourage your groups to contribute additionally to Intergroup. One group is passing a separate can following their 7th Tradition basket.

Quarterly Administrative Subcommittee Report - James W. The sub-committee performed annual employee reviews for all paid Central Office staff. (December) A sick leave and vacation time policy was approved, coordinator gets 24 hours of sick leave and vacation time per year and the assistant coordinator 16 hours of sick leave and vacation per year, with an added 9 paid holidays per year. Made sure the policy adheres to recently passed state legislation. (February) Multiple candidates were interviewed for the open Central Office coordinator position. The Committee voted unanimously to hire Jim W. as the new Central Office coordinator. (January). The Committee voted to bring a recommendation to Intergroup to amend the bylaws to include sobriety requirements for Administrative Subcommittee members-at-large and committee chairs. (March) An annual fee was paid to remove advertisements from the online calendar on the aatucson.org website. (April)

Central Office - Jim W. State & Federal Taxes are paid. Grapevine prices have been updated to reflect the price increase. One Home Answering Service shift is available; the 3rd Monday from 6:00 A.M. to 9:30 A.M. It is a once a month commitment. It requires 1 year sobriety, 30 minutes of training, and the willingness to do this valuable service work. The roofs on both storage sheds have been sealed. Please take back to your group that a group has volunteered to host the New Years Alcothon but is seeking help. Christmas Alcothon is still open! Maureen A. is the new editor of our newsletter, Just for Today. Great Job! James H. has volunteered to work on the "Mark on the Gate" book and could use some help. Central Office is open weekdays 9:30 A.M. to 5:30 P.M. Stop in and say Hi, have coffee, and maybe do a little service work.

Corrections - Tom T. Corrections is doing well. We have meetings at all units and institutions, many have multiple meetings. There is always plenty of need for volunteers. The Corrections Committee is thinking about moving from Intergroup to District to relieve some financial and time responsibility from Intergroup. In many areas, the Corrections Committee is under District or they are an autonomous committee. District needs to vote to allow the committee to make the move.

Bridging the Gap - Tom T. for Dante G. We met last week Sunday April 2, and some key points came up. We have no info online, one from our committee members will work with the Intergroup web servant to get us online on the Tucson Area Intergroup website. A brief presentation is available to all home groups if they would like more information on BTG. The presentation usually takes about 15 to 20 min. Luis from the Spanish community is plugging along nicely. He inquired about a standing Bridge the Gap committee at Area 03. A meeting in Cochise County has invited us down or up April 29th to give a presentation. They will volunteer as contacts and may even start up a BTG committee. Treatment patients continue to trickle in. Our recent bridge was a gal from Phoenix and met at the Eastside meeting place. More cards will need to be printed.

Treatment - Jim W. for Eric N. The Treatment Committee met on April 5th at Central Office, 6 attended. Dr. Sarah Howard, Community Living Center at the Veterans Admin Hospital asked if AA could bring meetings to the facility weekdays 6-7 p.m. and/or Sundays 2-3 p.m. She can be contacted at 792-1450 ext. 6549. Our goal for this month's meeting was to split out the treatment center list to start making calls to find out if centers/half-way houses have AA meetings. If so, when and if more are needed. If not, can we be of service and also explain how Bridging The Gap works. Members of the committee have taken 5+ centers each to call.

Public Information / Cooperation with Professional Community - Susan K. & Ken C. The committee met on March 22, there were 6 people in attendance. Representatives from 5 Home Groups, one new rep. Committee members are providing AA pamphlets to public libraries. The committee discussed more aggressively re-addressing bus stop ads and assigned a volunteer to research. TPD: Request came through Alanon RE: AA Literature for Police Cruisers. Will need to research further. Our Committee discussed possibilities and Traditions concerns. We have not heard back from TPD as of yet and have made no final decisions. Please feel free to contact Susan or Ken with any questions. Our next meeting will be Wednesday April 26 at 5:30 p.m.

Grapevine - Dennis W. The Grapevine Committee meets the first Sunday of odd months so we did not meet in April. Our next committee meeting will be May 7, 2017. Our online Grapevine for Corrections has collected enough funds for us to order 45 annual Grapevine subscriptions and 20 annual La Vina subscriptions to be taken into the prisons and jails. Thank you to our community for their generous contributions to make this possible. 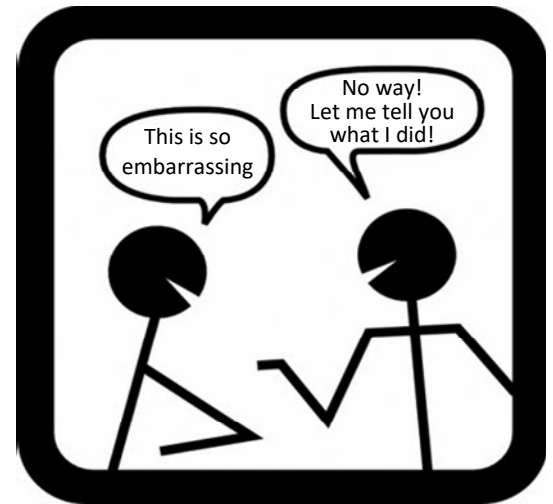
