# 9



### Step Nine: (Recovery)

Made direct amends to such people wherever possible, except when to do so would injure them or others.

### Tradition Nine: (Unity)

AA, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.

### Concept Nine: (Service)

Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

This one sounds simple. And, true, it does not involve some of the more complicated mental probing required by several of the other Steps. Having already made a list, in applying the 8th Step, *"of all persons we had harmed, and became willing to make amends to them all,"* the path is clearly defined with all stops plainly marked. All we have to do now is start doing.

But the "doing" is not easy. It takes considerable courage to confess a wrong, even in private, and much more courage to confess it to the person against whom the wrong was committed.

The list very likely includes one or two previous employers whom we deceived in one way or another; friends whose friendship we abused; relatives whose sense of blood obligations we exploited; the mate whose trust, patience and persistent hopes we flaunted. To each we owe a debt, large or small, and merely saying "we're sorry" does not discharge the debt.

In fact, we actually do not have the right to the inward ointment that comes from saying we're sorry, unless we also have within us a sincere willingness to repay in full, whatever effort this may cost, and an equally sincere determination not to repeat the wrongs against anyone.

Most of us, by the time we reach A.A., have been going around for a great many years saying "we're sorry" after each wrong and lightly thinking that these words made everything all right again. We've been annoyed if someone did not seem to accept our apologies as meaning much. How many can hark back and hear himself saying, petulantly, "What's the matter with him? I said I was sorry, didn't I?"

The 8th and the 9th Steps call for something more substantial, more tangible, more meaningful than words spoken casually. If it's money that is owed, it has to be paid back to the limit of ability to pay. If it's a debt of meanness, it has to be paid off with kindness. If it's neglect, as it is so often of one's family, then it can be balanced only by consideration and thoughtfulness. And let's not forget that debts of this kind--of neglect, thoughtlessness, mistreatment--have been piling up for years. They can't be paid off in two weeks.

The qualifying phrase, *"except when to do so would injure them or others,"* should prevent anyone from being righteously bullheaded, or stupidly "noble" about this. We are scarcely making amends if we dig something out of the past in which we had a part that will hurt someone else. The privilege of confession does not extend that far.

A helpful guide in the application of the 9th Step is the reminder that by making amends, where we can, we are doing no one else a favor; a favor is done us if those we have wronged accept our offer.

## **Tucson Area Intergroup, Inc. (TAII) Committee Meeting Minutes – August 9, 2015**

Chair John A. opened the meeting at 1:30PM with the Serenity Prayer.

**NEW INTERGROUP REPRESENTATIVES (IGRs):** Matthew K. from Experience, Strength and Hope; Elaina A. from Westside Primary Purpose; Susan O. from Honest, Open and Free; Victor from Happy Destiny and Efrain from Tucson Into Action.

**SECRETARY'S REPORT: NANCY S. for JAMES W.** Nancy R. brings motion to approve minutes and Ann seconds; motion passes unanimously.

**TREASURER'S REPORT: NANCY S.** Current available funds: \$31,916.38, which is 57.4% of our prudent reserve of \$55,631.90. Primary reasons for the reduced balance: *printing costs* for new meeting schedules (a quarterly expense) and *lower donations* from groups/individuals. July tends to be a lower month for contributions; asked Intergroup reps to remind home groups to send contributions as soon as possible as funds allow.

**ADMINISTRATIVE SUBCOMMITTEE: NANCY S. for JAMES W.** We did not have a quorum; reinforced John's comment that a new board member would be identified and approved during New Business.

**CENTRAL OFFICE REPORT: AARON B. - 882-7422 (Central Office)** Reggie Taylor is the Central Office Coordinator, Lynne Lovejoy is the Assistant Coordinator, and Aaron Botelho is the Substitute Coordinator. Central Office is open Monday through Friday from 9:30 AM to 5:30 PM, the cash register closes at 5:00 PM. An update on Reggie's absence was given; please keep her and her family in your thoughts and prayers. All Home Answering Service positions are filled at this time! An annual subscription of *Just For Today* can be purchased for \$12.00. The *Just For Today* newsletter will be mailed to you monthly. Last month, we had a wish list for a new conference table, a lap top computer and a small refrigerator. We received two conference tables and a lap top computer is on the way! We still need a little refrigerator, approximately 18" wide X 18" high X 18" deep. We need more individuals who can make 12 Step calls during the day, night and late night. We also need Spanish speaking and young 12 Step callers. Most 12 Step calls require a phone call rather than going to the person's location; unless the 12 Step caller chooses to do so. Be sure to take someone with you if you decide to meet the person. The payroll income taxes for July 2015 were paid.

**CORRECTIONS REPORT: TED M.** Corrections Committee Purpose: To carry the message of AA in the form of meetings, literature, and correspondence to alcoholics confined to an institution. Thirteen individuals attended the last meeting. The 2015 Arizona Area Corrections Conference was on July 18 in Sierra Vista. The purpose was to help create/maintain better relationships with corrections professionals in AZ. Over 100 attended including several from Tucson. State Prison Wardens and staff from Douglas and Tucson attended, as did Mar Kuhlman from ADC Administration in Phoenix. Bids for next year's Area 03 Corrections Conference will be heard at the upcoming August Assembly, August 21-13, in Lakeside. **Federal Prisons:** At this time, no new volunteers are being added due to staff transitions. Contact Tom C. at 520-428-9431. **Arizona State Prison – Tucson:** Recently held a 5th Step Workshop on the Manzanita Yard. Recently held a 4th Step Workshop at Santa Rita Unit and will host a 5th Step Workshop on August 12. A meeting began again at the So. Regional Community Corrections Center; all is well. Contact Dennis W. at 520-977-8149. **Pima County Jail – Men:** Due to recent staffing changes at P.C. Adult Detention Center, it is not clear who will handle clearances and orientation for AA volunteers. A letter describing AA and our corrections meeting format was sent to PC ADC; awaiting response so we can re-establish a relationship with a volunteer coordinator. Contact Jack W. at 520-906-4888. **PC Jail – Women:** Meetings are continuing. See notes regarding P.C. Adult Detention Center. Contact Colette B. at 520-909-4190. **Tohono O'odham Nation Jail – Sells, AZ:** One pod meets weekly, and there are seven pods, so meetings can be far apart for individual inmates wishing to attend. Earl A. is organizing the annual Thanksgiving Alcolthon; last year the entire TO Jail inmate population attended. Contact Whitey S. 425-772-7882. **Pima County Juvenile Detention Center:** The 2nd/4th Saturday speaker meeting continues. Working to get more meetings and more volunteers allowed inside. Contact Ted M. at 520-907-7531. **Saguaro and Red Rock (CCA) Prisons – Eloy, AZ:** Sunday meetings held at the Saguaro and Red Rock units. More volunteers are needed. Contact Ted M. at 520-907-7531. **Marana Community Correctional Treatment Facility – Marana, AZ:** The Saturday 7-8PM meeting is well attended; additional volunteers are needed. a meeting in every Tuesday from 7-8 PM and 2.) Los Altos requested a co-ed meeting every Wednesday from 7-8 PM.

**COOPERATION WITH PROFESSIONAL COMMUNITY (CPC): JIM W.** Ten members attended last meeting. AA cards are being distributed to libraries and Codac. The three AA meetings and informational table at the Southwest Behavior Conference planned for August were cancelled. The conference changed its policy and asked AA to pay a fee to attend. They were reminded that AA provides a service but they were adamant about the fee so we will not attend. We apologize and thank everyone for your support. Motion passed to co-host New Year's Alcolthon with Treatment and Corrections. A CPC/PI workshop is being considered. More on this later. CPC/PI meetings are held the fourth Wednesday of every month 5:30 P.M. at Central Office. Next meeting is August 26, 2015..

**AA OF THE AIR: BRYAN** Recording all speakers at this time even though there is no radio station.

**GRAPEVINE (GV): AARON for VIVIAN W.** Currently two projects are focused on generating GV subscriptions for Corrections to take into jails and prisons, as follows: A letter was given to IGR's encouraging home groups to purchase one GV subscription, for Corrections, every three months at a cost of only \$2.23/week. The GV Committee has collection cans if a home group wants one. Several home groups have adopted this policy. **OLD BUSINESS:**None

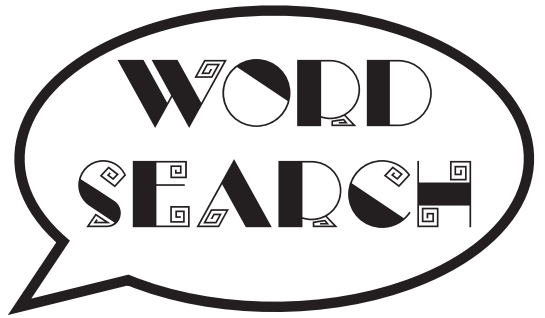
