Becoming a Part Of

Like step two, step three was easy for me when I first arrived in AA. I had the God of my childhood, it worked for me, and it was quite easy to turn my life over on a daily basis. Later, however, after I lost that faith, step three became much more challenging for me. What do I turn my will and my life over to now? How do I make a decision to turn my will and my life over to something I am not even sure I believe in? Would that not make me a hypocrite? The Big Book assures me though, “the Realm of the Spirit is broad, roomy, all inclusive; never exclusive or forbidding to those that earnestly seek. It is open.” Thus, I began to seek a new way of practicing step three.

For me, step three was about finding the willingness to direct my thinking and my actions outside of myself, trying to rid myself of selfishness, and looking for what I could contribute to life. If I see myself as a part of a vast universe made up of energy and atoms, then I can easily see that I am not in charge, for it would be quite the job to be in charge of the universe and I am not qualified. If I wake up in the morning and focus my thinking on what I can contribute to this universe, my thinking is directed away from self-seeking motives and my day is better.

I had a sponsor who would often say to me, “You don’t have to do it right, you just have to do it differently.” Her words often replay in my head. What can I do differently today that will make things better? The list of things I can do differently today is vast and endless: read the big book, talk to another alcoholic, read the Daily Reflections and actually reflect on it, allow a car in traffic to get in front of me, offer to help someone, pick up litter, clean my house, plant some flowers, spend time meditating, do service work, make a conscious effort not to complain, etc. When I shift my focus to being a helpful member of the universe, I feel happier. Who would’ve guessed that to make me happy I needed to spend less time focused on me? This is how I am relieved of the bondage of self and how I begin to feel a part OF rather than apart from.

Intergroup Meeting Minutes

February 14, 2021. The meeting opened at 1:30pm with the Serenity Prayer.

New Intergroup Reps. Elizabeth A. – 12 Stepping Sisters, Rhonda B. – Smoke Free Nooners, Kathleen M. – Rincon Group.

Secretary's Report – Maureen A. Sara B. made a correction to the Spanish Speaking Liaison Report in minutes. The minutes should say Hispanic Intergroup will use “literature raffle” to generate funds not “literature racks”. Steve made a motion to accept the January minutes with Sara’s correction. Al M. seconded the motion. The motion passed.

Treasurer's Report – Brian H. We have current available funds for operating expenses totaling \$64,741 which is equal to 6.7 months average operating expenses. We also have established a savings account holding our prudent reserve of \$15,578 (13.43%) of annual budget. We will deposit \$1,822.09 from our checking to our savings account to bring the total of our prudent reserve to equal 15% of our total operating expenses according to the TALL bylaws. This is necessary because our budget increased in 2021. Al M. made a motion to accept the Treasurer’s Report. Pat S. seconded the motion. The motion passed.

Central Office – Lynne L. Central Office is still officially closed. However, Jim and Lynne are at Central Office during the middle of the day from 10:00am to 2:00pm. If you need to purchase chips or literature, you can stop by Central Office at that time or call 882-7422 and leave a message and one of them will call you back to set up an appointment to come by. The Home Answering Service has 1 shift available on the 5th Sunday of the month from 1:00pm to 5:30pm. Call Central Office at the same number as above if you are interested in taking that shift. Jim or Lynne will call you back and mail you a Home Answering Service packet and train you over the phone. Central Office needs 12-step workers to talk to alcoholics who call the hotline. If interested, please call Central Office.

Corrections – Emil B. There was a Corrections Committee Meeting on January 16th. They discussed the importance of bringing literature into the jails and prisons. This can be done directly by the publisher to a specific inmate. The Grapevine does this. Call the Grapevine at (800) 631-6025 (English speaking) or (800) 640-8781 (Spanish speaking) to have them send a subscription to an inmate. It is also important to bring AA published literature for inmates into the jails and prisons. Some inmates have the little red Big Books but they are not published by WSO. They are published by Anonymous Press who profits from the sales of these books. The soft cover blue Big Books are published by AA. This supports WSO when we purchase them.

Bridge the Gap – Juliet. No report

Treatment – Terry. There are 3 live in-person treatment meetings. There are 5 zoom meetings for nursing homes and treatment centers. Please switch the Treatment meeting listing on the TALL calendar from in-person to a Zoom meeting, same time.

PI/CPC – Pat S. Committee meets at 5:30 on the last Wed. of month via Zoom. Send your group representatives. They met this past January 27. They are working on an initiative to create a Zoom “take a professional to a meeting” program. Looking for volunteers to do this. They have a packet with a format and follow-up surveys. He will send packet to Jim and Lynne for availability at Central Office. You can email Pat for information at Pscott2372@gmail.com. Please get the word out to your groups.

Grapevine – No report.

Events Coordinator – Position is open. No report.

Historian – Alan will be working with Laurie B. to get the new Mark on the Gate together. Would like someone to nominate her as Historian. Would like to document AA during COVID if you have any information send to Central Office and they will forward to Alan and Laurie.

Monthly City-Wide Speaker Meeting – Rob C. On hold until further notice.

Homebound Exploratory Committee – Karen B. She is going to PRASSA to learn what other groups are doing during COVID.

Spanish Speaking Liaison – Sara B. For now, the AA Tucson Spanish meetings will not be updated on the Tucson AA website until things settle down with the pandemic, as things are still in flux. She has been in touch with the Grapevine Intergroup Rep. and will be conveying a message to the La Viña rep (who only speaks Spanish), that La Viña is welcome to share a table at events with Grapevine. Question was raised at Spanish Intergroup whether Central Office has literature in Spanish. Spanish Intergroup has a literature rep, but no office space at this time. The Response

from Central Office was that when Spanish Intergroup started, Central Office donated all Spanish literature to them at that time.

Area Liaison/Vice Chair – James W. District 11 Treasury has a bank balance of \$6810.40. \$3060.40 available after \$1500 prudent reserve, and \$2250 budget reserve. District 11 Groups have mixture of meeting types. Some meet only online, some meet only in person, some meet separately online / in-person, and some meet in integrated in-person / online meetings. Sub-districts are meeting online and doing ok but have some drops in attendance. Exception is District 11-111 which did not meet. District 11 is considering bidding for the 2022 Arizona Area Convention. More discussion and information to follow. District 11 is hosting the virtual Arizona Area August Assembly. Will be looking for volunteers soon. Flyer should be coming soon. PRAASA (Pacific Regional AA Service Assembly) 2021 is being held online 3/5-3/7. I plan to attend. Arizona Area Pre-Conference Assembly will be held online 3/26-3/28. I have not yet received any information on agenda or items to be discussed. Will hopefully have all the information for next month's Intergroup meeting.

Al-Anon Liaison – Brian C. Alanon Founders day is Feb. 27 from 1:00pm to 2:30pm. We will be celebrating 64 years Tucson and Southern AZ. There will be an AA speaker, an Alanon speaker and an Alateen speaker. It will be on Zoom. Go to www.so-az-alanon.org. Turbo charger recovery still going on. More information on Alanon website.

Old Business – Continuation of Elections: Intergroup Chair – Steve A. volunteered. Jim H. motioned to vote in Steve A. Al M. seconded. Steve A. voted in unanimously. **Historian – Al M.** nominated Laurie B., Jim H. seconded. Laurie voted in unanimously. **Events Coordinator –** No nominations. Bring back to your groups that we need an Events Coordinator. **New Administrative Sub-Committee Members (4) – Al M.** will stand for one position. Jim H interested. Laurie moved to nominate both by acclamation – motion passed. Ashley K. interested. Ashley voted in unanimously. New Subcommittee members should send your email address to Central Office. Al needs to be texted the information because he does not have email.

Possible Contribution to GSO – Brian still waiting for answer from GSO as to whether they can accept contributions from TAIL. Terry brought information that GSO is not in need of contributions. Mary will take the information back to her group to see if they still would like the motion to contribute to GSO to be made. James mentioned that for future reference Brian should still work on finding out whether GSO would take contributions from TAIL.

New Business – Al M. Should we explore possibility of helping Spanish speaking Central Office financially in some way so they can rent their own Central Office? James said to put it on the Administrative Subcommittee agenda for next month to discuss.

Intergroup Rep. Announcements – Lynne stated that new Intergroup Representatives should send their full name, mailing address, phone number, group name and email to Central Office. There is only One Key

Practicing Step Three is like the opening of a door which to all appearances is still closed and locked. All we need is a key, and the decision to swing the door open. There is only one key, and it is called willingness. Once unlocked by willingness, the door opens almost of itself, and looking through it, we shall see a pathway beside which is an inscription. It reads: "This is the way to a faith that works." In the first two Steps we were engaged in reflection. We saw that we were powerless over alcohol, but we also perceived that faith of some kind, if only in A.A. itself, is possible to anyone. These conclusions did not require action; they required only acceptance.

Like all the remaining Steps, Step Three calls for affirmative action, for it is only by action that we can cut away the self-will which has always blocked the entry of God—or, if you like, a Higher Power—into our lives. Faith, to be sure, is necessary, but faith alone can avail nothing. We can have faith, yet keep God out of our lives. Therefore our problem now becomes just how and by what specific means shall we be able to let Him in? Step Three represents our first attempt to do this. In fact, the effectiveness of the whole A.A. Program will rest upon how well and earnestly we have tried to come to "a decision to turn our will and our lives over to the care of God *as we understood Him.*"
